Hunton & Williams LLP Advises Banco Sabadell on its Agreement to Acquire Mellon United National Bank

Hunton & Williams LLP represented Banco de Sabadell, SA, Spain's fourth largest bank, in connection with its agreement to acquire Mellon United National Bank ("MUNB"), a wholly owned subsidiary of The Bank of New York Mellon Corporation. The stock purchase transaction, which is subject to regulatory approval, is expected to close by the first quarter of 2010. The acquisition will be Banco Sabadell's third significant purchase transaction in the United States, following TransAtlantic Bank (May 2007) and BBVA's private banking business in Florida (April 2008). As a result, Sabadell's total business volume in the United States will be approximately \$6.4 billion dollars (\$4.3 billion dollars in managed assets and \$2.1 billion dollars in loans).

Alonso said: "This acquisition may be a good harbinger; it underscores how in these tough economic times, foreign financial institutions still have confidence in the US banking sector. Spanish banks, in particular, have been bullish about

opportunities in Florida and the United States, generally, and Sabadell's investment is a positive statement for our community."

Sabadell's internal legal team was led by Anna Oestereicher, its US general counsel, and from Spain by the Bank's general counsel, María José García Beato, and Oriol de Nadal Alier. The Hunton & Williams team worked closely with The Bank of New York Mellon's internal counsel, led by Marcia Wallace and Becket Sorce. "Internal counsel at Banco Sabadell and Bank of New York Mellon were the key to this transaction," said Alonso. David Yates added, "The transaction was largely accomplished due to the excellent working relationship established by Anna Oestereicher with the Bank of New York Mellon attorneys."
