Real Estate Capital Markets 2014 Year in Review

2014 Highlights

During 2014, our team handled more than **65 real estate capital markets transactions aggregating more than \$8 billion**. We represented issuers in approximately 20 transactions aggregating nearly \$2 billion. We represented underwriters in approximately 45 transactions aggregating more than \$6 billion.

REITs focused on **hotel**, **industrial** and **retail** properties combined to make up approximately one-third of our transaction activity, with approximately another third of the transactions involving **mortgage REITs** and other **specialty finance companies**. The balance of our 2014 activity related to REITs that own **agriculture**, **health care**, **multi-family/residential**, **office**, **storage** and other diversified assets.

Approximately two-thirds of the transactions we closed were **public common stock offerings**, with the remainder being senior notes offerings, convertible notes offerings, preferred stock offerings and private transactions, including Rule 144A/Reg D equity offerings, as well as merger and acquisition transactions.

We serve as counsel on 25 ongoing **at-the-market, or ATM**, programs for real estate and mortgage companies, with our work split relatively evenly between issuer representation and placement agent representation.

We also represented several clients in connection with non-traded REITs internalizing their management and transactions designed to provide liquidity to their stockholders, including <u>landmark transactions for The Inland</u> Real Estate Group of Companies.

Thought Leadership

In 2014, our Real Estate Capital Markets team provided thought leadership in areas such as distressed mortgage loan guidance for REITs; proposed regulations that would clarify definition of "real property" for REITs; REIT income test treatment of offsetting hedges; tax-planning strategies used by real estate partnerships and their partners; tax reform proposals; the business judgment rule as it applies to externally managed companies; and the SEC's "Regulation A+" proposal.
